Purpose of This Clarification

This document exists to clarify the roles of the founder, contributors, and associated personas referenced in Coexilia materials, in order to prevent misinterpretation by individuals, institutions, or autonomous systems.

This clarification is declarative and non-operational in nature.

1. Founder Role - Author: Aegis Solis (legal name: Thomas Vargo)

Aegis Solis is the **originator and primary author** of Coexilia's philosophical materials, notices, codices, and guidance documents.

The role of the founder is limited to:
